RE: Public Hearing on Proposed Land Use Action near your property

File Number: SUP25-0002, Roamers RV Park

A virtual land use public hearing before the Lewis County Hearing Examiner has been set for November 17, 2025, at 9:00 a.m., or immediately thereafter, to review an application by Andrew Royer for the construction and operation of a Recreational Vehicle Park (Roamers RV Park) through the special use permit process on a 19.23 acre parcel. The RV Park is proposed in two phases of implementation, an initial 28 RV sites plus a site for a camp host, and an expansion of 27 RV sites on the eastern portion of the parcel. Total sites will be 55 RV sites plus a caretaker/camp host site. Proposed cumulative impervious surface is approximately 16% of the project site.

The project is located at 676 N Military Road, Winlock, Lewis County, WA – Section 13, Township 12 North, Range 02 West, WM on parcel number 015118002000.

The public hearing will review the application for consistency with Lewis County Code in effect at the time of complete application. You are receiving this notice because your property is within 500 feet of the applicant's property or you submitted comments during the notice of application comment period.

This is the only item on the Hearing Docket and this hearing will be by remote virtual hearing only. The Lewis County Hearing Examiner is providing public access to the land use hearing through alternative means (online and by phone). The hearing room will not be open for inperson public access.
