**WHEREAS**, said application and all related materials have been reviewed by the BOCC and found appropriate for further proceedings; and

NOTICE IS HEREBY GIVEN that the Board of County Commissioners, Lewis County, Washington (BOCC), has received an application for the renewal of a non-exclusive franchise from Olympic Pipeline Company, L.L.C., for the installation, construction, operation, and maintenance of a pipeline for purposes of transmission of petroleum and petroleum products within Lewis County rights of way in the following description:

Section 27, T15N, R1W Big Hanaford Rd, also Section 17, T14N, R1W Little Hanaford Rd and Jones Rd, also Section 29, T14N, R1W Proffitt Rd, also Section 31, T14N, R1W Centralia Alpha Rd, also Section 7, T13N, R1W Logan Hill Rd, also Section 18, T13N, R1W Taylor Rd, also Section 19, T13N, R1W Jackson Hwy, Vista Rd, E Forest Napavine Rd, also Section 31, T13N, R1W Koontz Rd, also Section 6, T12N, R1W E Avery Rd, also Section 7, T12N, R1W Meier Rd E, also Section 18, T12N, R1W Park Rd, also Section 19, T12N, R1W Hanson Rd and Hart Rd, also Section 30, T12N, R1W Frost Rd, also Section 7, T11N, R1W Drews Prairie Rd and Toledo Vader Rd, also Section 25, T11N, R2W Jackson Hwy S and Smokey Valley Rd.


RCW 36.55.040 requires that notice of hearing be posted in three public places in the county seat of the county at least 15 days before the day fixed for hearing and also published two times in the official newspaper of the county, the last publication to be not less than 5 days before the day fixed for hearing.

2026. Written comment must be clearly marked "Written comment for March 10, 2026 Hearing" and must be received by 10 a.m. March 9, 2026.
