

**NOTICE OF PUBLIC HEARING  
BEFORE THE LEWIS COUNTY HEARING EXAMINER**

NOTICE IS HEREBY GIVEN that the LEWIS COUNTY HEARING EXAMINER will hold a land use public hearing on Friday, March 13, 2026, starting at 9:00 a.m., or immediately thereafter for the purpose of taking public testimony and rendering a decision concerning a **wireless communication facility application** (WCF25-0002) from Harmoni Towers. This hearing will be a hybrid hearing with remote and in-person options available. This is the only hearing on the agenda docket.

Project: Verizon Wireless proposes to construct a new 150 foot monopole tower with attached antennas and cabling along with ground mounted equipment cabinets placed within a 50x50 foot fenced area. The facility will be served by a 20 foot wide access road and utility connections. The project is located at 262 Skyview Drive, Mossyrock on tax parcel number 028513011000

The Lewis County Hearing Examiner is providing public access to the land use hearing in person and through alternative means (online and by phone).
