NOW THEREFORE BE IT RESOLVED that a hearing before the Board of County Commissioners is hereby scheduled at or after 10 a.m. on March 24, 2026, to receive testimony on Ordinance 1373, which would amend Chapter 2.25, Hearing Examiner, of Lewis County Code; and
