**WHEREAS**, Lewis County's 3R Program is listed on the 2020-2025 TIP; and

**WHEREAS**, the BOCC wishes to complete maintenance and 3R projects on various roads in Lewis County in 2020 and needs to purchase crushed screenings; and

**WHEREAS**, pursuant to Resolution 18-116, the BOCC adopted the 2018 Standard Specifications for Road, Bridge, and Municipal Construction and this proposal shall be performed by contract in accordance with these specifications.

**NOW THEREFORE BE IT RESOLVED** that the Department of Public Works is instructed to issue a Call for Bids and Contract Specifications for the 2020 Rock Purchase. Bids for the proposal shall be submitted to the Clerk of the BOCC (351 N.W. North Street, Room 210, CMS-01, Chehalis, Washington 98532) by or before 11:00 a.m. on Tuesday, March 31, 2020, and will be opened on or after 11:00 a.m. on March 31, 2020.

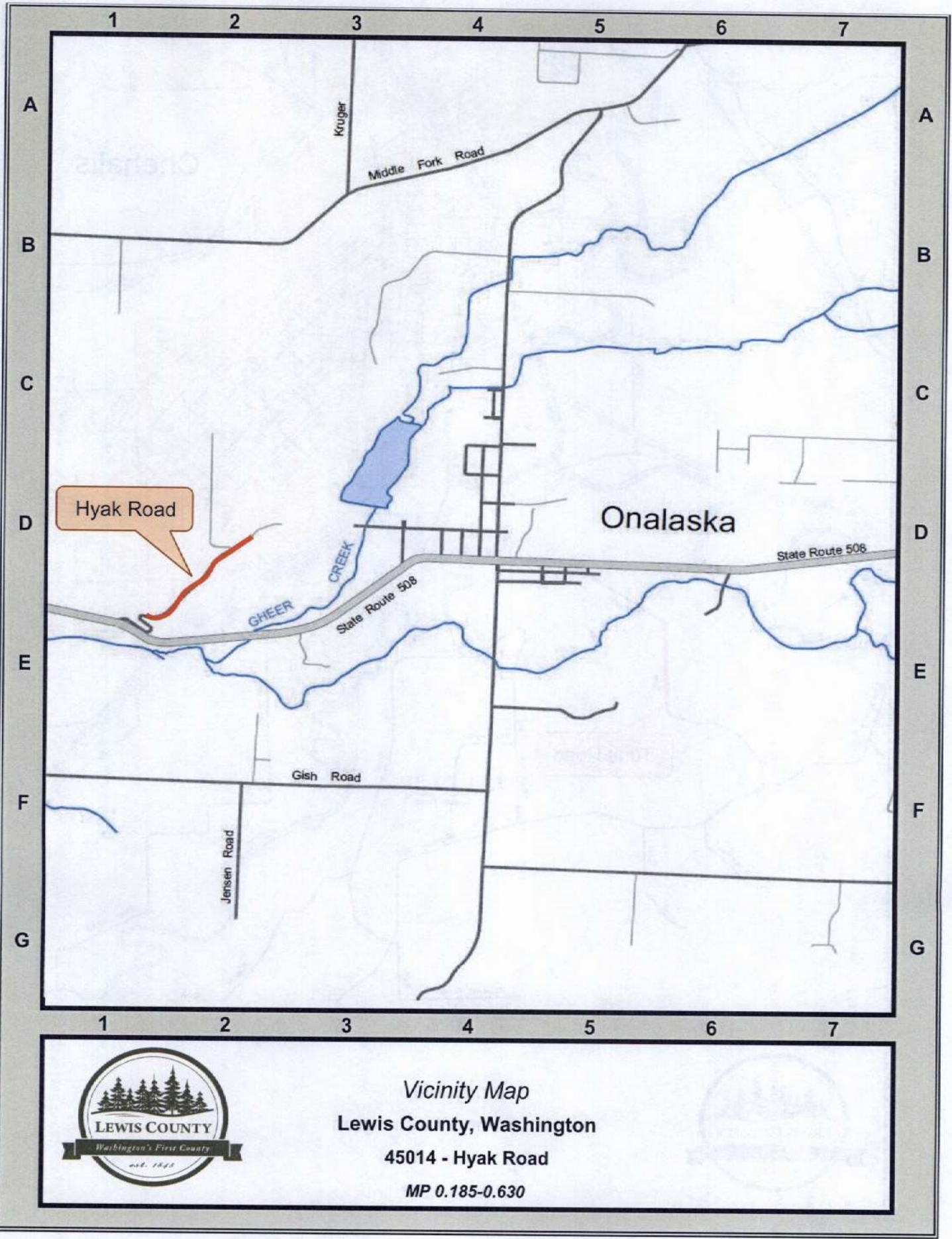

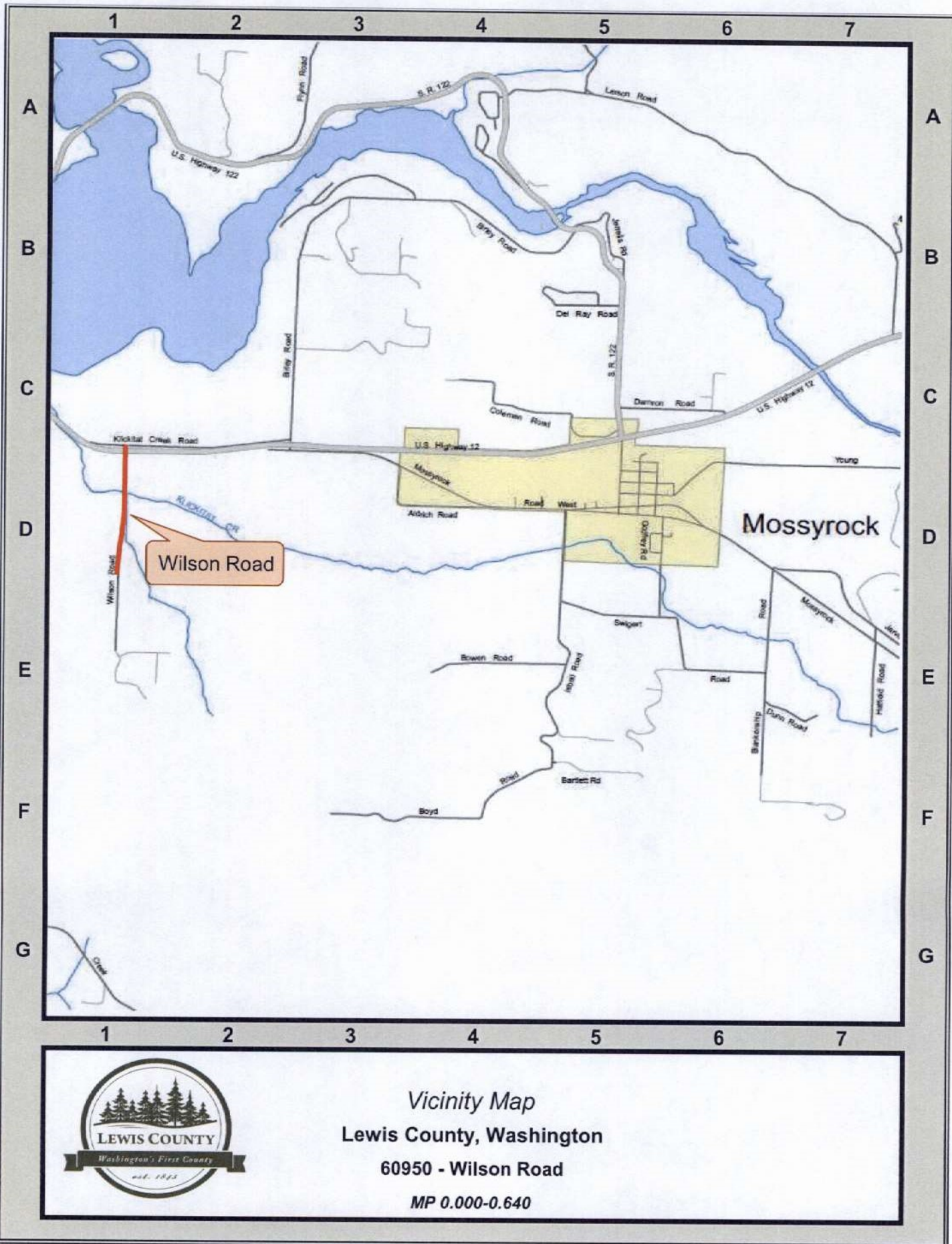


Vicinity Map
