NOTICE OF PUBLIC HEARING AND DECLARATION OF  
THE BOARD OF COUNTY COMMISSIONERS TO  
DISSOLVE DIKAGE AND DRAINAGE DISTRICT #1 FOR  
LEWIS COUNTY PURSUANT TO CHAPTER 36.96 RCW  
AND DIRECTING THE SETTING OF A PUBLIC  
HEARING

**WHEREAS**, Dikage and Drainage District #1, also known as Davis Lake Diking and Drainage District, being found entirely within Lewis County; and

**WHEREAS**, Chapter 36.96 RCW provides a mechanism for the dissolution of inactive special purpose districts to be initiated by the county legislative authority within whose boundaries the special purpose district lies; and

**WHEREAS**, the Lewis County Auditor has determined that there is no record of activity for Dikage and Drainage District #1 from 2014 to the present; and

**WHEREAS**, the Lewis County Auditor has determined that there is no record of election or appointment of elected members for Dikage and Drainage District #1 from 2012 to present; and

**WHEREAS**, the District appears to meet a criterion for being inactive and thus subject to dissolution under Chapter 36.96 RCW.

**NOW THEREFORE BE IT RESOLVED** the Board of County Commissioners declares and establishes its intent to dissolve Dikage and Drainage District #1 pursuant to Chapter 36.96 RCW; and

**NOW THEREFORE BE IT FURTHER RESOLVED** the Board will hold a public hearing on the proposed dissolution of Dikage and Drainage District #1 on August 17, 2020, at or after 10:00 a.m. or at such time later that day as may be necessary due to schedule changes pertaining to COVID-19. The hearing will take place at the Lewis County Courthouse, Commissioners' Hearing Room, 351 NW North Street, Chehalis, Wash., as set forth in the Notice of Public Hearing attached hereto.
