THE TEMPORARY CLOSURE OF PLEASANT VALLEY
ROAD TO ALL THROUGH TRAFFIC

WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, it is necessary for Lewis County to repair a bridge on Pleasant Valley Road at MP 2.46; and

WHEREAS, it will be necessary to close Pleasant Valley Road between Haywire Road and Conrad Road to all through traffic during the period of such work; and

WHEREAS, Pleasant Valley Road will remain open for local access from either end up to but not beyond the point of closure between MP 2.43 and MP 2.50, and other county roads are available for detour.

NOW THEREFORE BE IT RESOLVED that, pursuant to RCW 47.48.010 and .020, beginning 7:00 a.m. August 17, 2020, and ending 5:00 p.m. October 2, 2020, Pleasant Valley Road between Haywire Road and Conrad Road in Section 32, Township 13 North, Range 2 West, and Section 5, Township 12 North, Range 2 West, W.M., shall be closed to all through traffic.

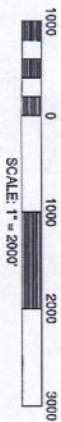

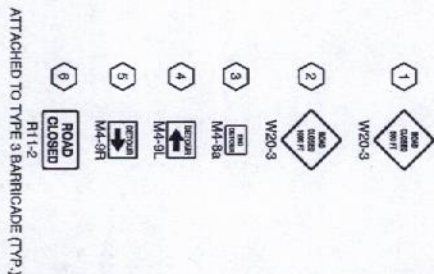
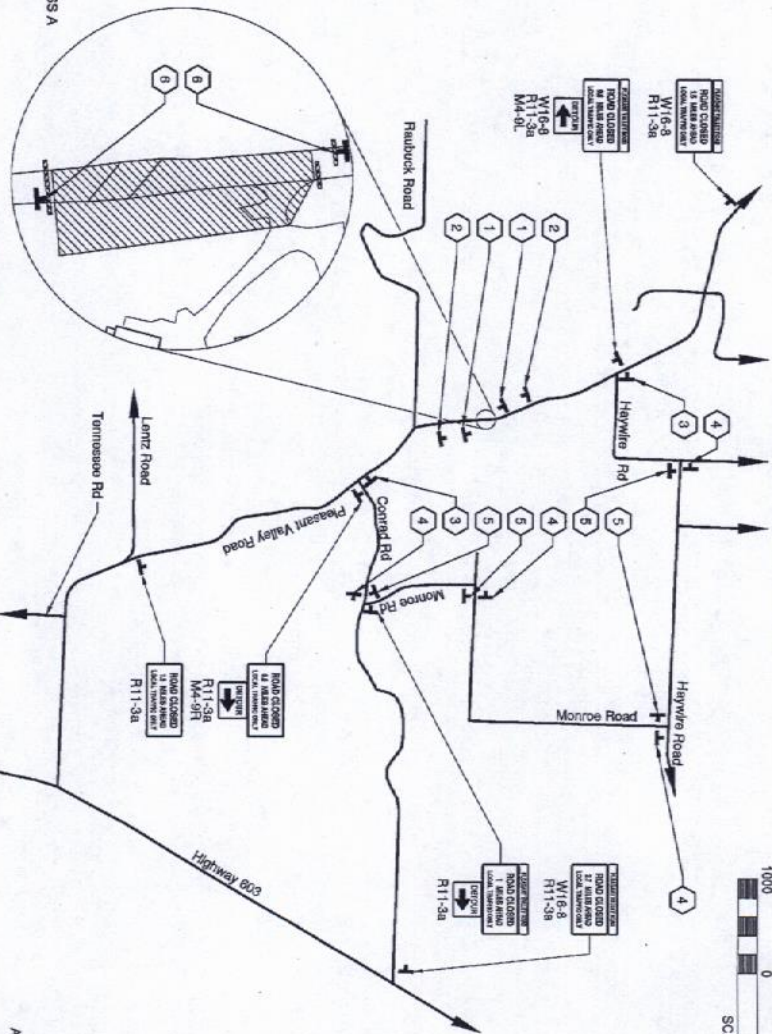
