WHEREAS, there is a need to hold a public hearing for the purpose of amending the 2020 budget for Current Expense and various funds; and

WHEREAS, all those wishing to speak for or against the amendment shall be afforded the opportunity to be heard. Said amendment will be available to review and can be obtained from the Board of County Commissioners' (BOCC) Office. Written comments may be submitted to the BOCC prior to or during said hearing.

NOW THEREFORE BE IT RESOLVED that a public hearing will be held before the Lewis County BOCC in the Historical Courthouse, 351 N.W. North Street, Chehalis, Washington, on the 28th day of September 2020. The hearing will be held on or after 10:00 a.m. to consider an amendment to various departments within the 2020 budget for Current Expense and various funds, increasing expenditures in the amount of \$6,798,741, an increase in revenue in the amount of \$5,501,674, and use of fund balance of \$1,297,067. COVID-19 funding through the CARES Act accounts for \$4,721,148 of the increased revenue total.
