NOW THEREFORE BE IT RESOLVED that expenditures in the amount of \$662,710 be increased and revenue in the amount of \$715,398 be increased, resulting in an increase in estimated ending fund balance in the amount of \$52,688. Funds will be placed in the budgets within Current Expense and other funds as indicated and distributed in the revenue and expenditure accounts detailed on "Schedule A." Funds may legally be transferred from one item to another within said budget.
