- III. Minutes from Regular Meeting of April 26, 2021

Motion by Gary Stamper and seconded by Lindsey Pollock to approve minutes of the April 26, 2021 regular meeting. Motion carried.

- VI. Transfer Station Operations
 - A. Community Litter Program Report 12 illegal dumpsites reported. Working with Dept. of Ecology for additional funding for the litter program.
 - B. Transfer Station Tonnages total tonnage for April was 7,907. Tonnage was 19% higher than the previous year.
 - C. Recycling Update CTS site had two paper boxes hauled weighing 13.99 tons and costing \$175.48 after hauling fees. This is a huge improvement compared to last April were we had 31.74 tons of contaminated recycling costing \$2,738.62 in disposal fees. ELCTS site had two glass boxes dumped due to contamination. We had a tire-recycling event in Morton where several hundred tires were collected. Pe Ell will be having a tire event on June 12 from 8 a.m. -2 p.m.
- VII. Miscellaneous Reports None
- VIII. Financial Reports
 - A. <u>Disposal District and Utility Income Statements</u> The District's statement showed a net revenue of \$5,653 for April of 2021, and the ending balance of District Fund 415 was \$3,142,606. Increased expenditures for the month were the hauling and disposal to the landfill, professional services for our feasibility study, wood chipping at the CTS site and 2 new 40-yard boxes for our recycling program.
- IX. Approval of Transfers from Solid Waste Disposal District #1 to Lewis County Solid Waste Utility

 Motion by Lindsey Pollock and seconded by Gary Stamper to approve payments and transfers in the amount of \$769,059. Motion carried.
- X. Staff Discussion
 - A. <u>Feasibility Study</u> Josh gave an update on our feasibility study. We are still looking at locations for future sites.
 - B. <u>Rates</u> Commissioner Swope requested to see projections for future rates increase.

^{*}Breakdown of building/facility rent: CTS monthly rent is \$51,000 and the ELCTS montly rent is \$1859. CTS monthly rent payments increased from \$38,700 to \$51,000 in Jan. 2010. \$38,700 goes toward a bond payment and \$12,300 is reserved in Solid Waste Fund 401 for capital improvements. Per BOCC Resolution #11-439, when the bond is fully paid in Dec. 2024, the entire \$51,000 payment will be reserved in the Solid Waste capital improvement reserve.
