The hearing will be held at or after 10 a.m. to consider an amendment to various departments within the 2021 budget for Current Expense and various funds, increasing expenditures in the amount of \$1,249,287 offset with an increase in revenue in the amount of \$649,274 and a decrease of fund balance of \$600,013; and

NOW THEREFORE BE IT FURTHER RESOLVED that the Clerk of the BOCC is hereby instructed to proceed with all appropriate and necessary notifications, posting and publication as required by law.
