- II. Verified quorum is present.
- III. Minutes from Regular Meeting of July 26, 2021 Motion by Lindsey Pollock and seconded by Sean Swope to approve minutes of the July 26, 2021 regular meeting. Motion carried.
- IV. Public Hearing None
- V. Board Measures and Proposals None
- VI. Transfer Station Operations Presented by Josh Metcalf, Director of Public Works
 - a. Community Litter Program Report Litter program coordinator cleaned up 14 illegal dumpsites with 3,540 pounds of garbage, 12 tires and 1 freezer removed.
 - b. Transfer Station Tonnages Total tonnage for July was 10,613, which was 28% higher than the previous year. Customer count for July was 16,867, which is 22% higher than the previous year. Commissioner Swope asked if other counties are effected with the increase in Solid Waste. Tom Rupert of LeMay/Waste Connections responded that he could speak to the fact that Grays Harbor County is experiencing an increase. Josh stated that as previously discussed development (demolition and construction) debris plays a role in this increase, including the contaminated dirt from the new Dollar General that ran through the facility in July.
 - c. Recycling Update No update
- VII. Financial Reports Presented by Josh Metcalf, Director of Public Works
 - a. Monthly reports July 2021
 - Fund 415 showed a net loss of \$100,740 and an ending balance of \$3,194,046. Fund 415 revenue per the Paradigm scale report for the month of July was \$1,022,931. Revenue listed on the monthly report reflects accounts receivables collected as of 7/31/21. The difference being charge account customers with outstanding balances.
 - Fund 401 expenses, purchased new lids for our recycle boxes, HDR invoices for our feasibility study, retrofit new lights at the CTS site, service flare system for Landfill & HHW disposal.
- VIII. Miscellaneous Reports None
- IX. Approval of Transfers from Solid Waste Disposal District #1 to Lewis County Solid Waste Utility Motion by Lindsey Pollock and seconded by Sean Swope to approve payments and transfers in the amount of \$750,131. Motion carried.

- X. Staff Discussion Presented by Josh Metcalf, Director of Public Works (Handouts provided)
 - a. Rate Discussion Josh explained the handouts. He asked the Board to give him direction to take the numbers to SWAC (Solid Waste Advisory Committee) for discussion and recommendations. Both Commissioner Swope and Pollock agreed and recommended further discussions with SWAC.
 - b. Interlocal Landfill Agreement Cowlitz Landfill. Preliminary conversations have taken place. Formal conversations are scheduled. Commissioner Swope asked how gas prices would affect things overall. Josh stated that he is taking gas prices and staffing shortages into account.
 - c. Equipment Replacement Excavator at CTS needs replaced. Funds are allocated to cover this purchase.
- XI. Announcements Josh Metcalf, Director of Public Works provided details regarding upcoming recycling events. These events will be covered by grants and help offset the non-continuation of the voucher program.
- XII. Adjournment With no further business, Motion by Lindsey Pollock and seconded by Sean Swope to adjourn the meeting at 2:00 p.m.



Discussion

This resolution sets 1:30 p.m., October 25, 2021, as the time and day for the Board of the Lewis County Solid Waste Disposal District to hold a public hearing about a proposal to increase the municipal solid waste (MSW) tipping fee charged at the Central Transfer Station (CTS) in Centralia and the East Lewis County Transfer Station (ELCTS) in Morton.

When the Lewis County Solid Waste Disposal District #1 (District) began operating the (CTS) in 1994, the MSW tipping fee was established at \$95 per ton. Defeasance of bonds reduced the District's financial obligations in 1997, and as a result, the District authorized the tipping fee lowered to \$82 per ton at the CTS and the ELCTS, which began operation in 1997. The District Fund 415 was profitable until the economy weakened, and MSW tonnage declined, resulting in revenue losses even though Solid Waste management reduced operating expenditures to alleviate declining revenue, as a result, the MSW tipping fee increased in 2014 by \$8 to \$90 per ton.

A review of the finances for Lewis County Solid Waste indicate a need to increase disposal fees. Reserves need built. They are at the minimum required amount. Equipment needs replaced. It has reached its life expectancy. Facility needs upgrades. It has reached its capacity to serve the needs of the Lewis County residents. The fee increases will be as follows: tipping fee \$100/per ton with a minimum of \$15/200lbs, bulky waste \$120/ton with a minimum of \$15/200lbs, yard waste (grass & leaves) \$90/ton with a minimum of \$10/160lbs, yard waste (tree limbs) \$60/ton with a minimum of \$10/160lbs and tires (passenger/light truck) \$5 with or without the rims.

According to RCW 70.95.212, the new tipping fee may be effective at least 75 days after haulers have been given notice so that solid waste collection companies have time to prepare and submit tariffs and rate filings for public comment; and to allow time for the Washington Utilities and Transportation Commission to review the collection companies' tariff requests.

PROPOSED FEE INCREASES AS FOLLOWS: TIPPING FEE \$100/PER TON WITH A MINIMUM OF \$15/200LBS, BULKY WASTE \$120/TON WITH A MINIMUM OF \$15/200LBS, YARD WASTE (GRASS & LEAVES) \$90/TON WITH A MINIMUM OF \$10/160LBS, YARD WASTE (TREE LIMBS) \$60/TON WITH A MINIMUM OF \$10/160LBS AND TIRES (PASSENGER/LIGHT TRUCK) \$5 WITH OR WITHOUT THE RIMS.

WHEREAS, the Lewis County Solid Waste Disposal District #1 (District) is responsible for collecting fees necessary to pay for the handling and disposal of municipal solid waste (MSW), pursuant to the following: RCW 36.58.130 states a Solid Waste Disposal District is authorized to collect fees necessary to pay for the handling and disposal of MSW; and LCC, Article II – Solid Waste Disposal District – Chapter 8.15.210 states that the District is authorized to "establish solid waste service charges within Lewis County to cover the cost of solid waste disposal; and,

WHEREAS, the District began operating the Central Transfer Station on April 1, 1994, and charged a tipping fee of \$95.00 per ton for MSW received at the facility, as authorized by District Resolution 001-94; and,

WHEREAS, District Resolution 004-97 authorized that the \$95.00 per ton fee be lowered to \$82.00 per ton. The defeasance of bonds reduced the financial obligations of the District and allowed the tipping fee to be lowered to \$82.00 per ton at the Central Transfer Station and the East Lewis County Transfer Station, which began operation in 1997; and,

WHEREAS, the District Fund 415 was profitable until the economy weakened and MSW tonnage at solid waste disposal facilities declined, although Solid Waste management reduced operating expenditures to mitigate declining revenue, as authorized by District Resolution 007-13; tipping fees were increased to \$90 per ton at the Central Transfer Station and the East Lewis County Transfer Station; and,

WHEREAS, A review of the finances for Lewis County Solid Waste indicate a need to increase disposal fees. Reserves need built, equipment needs replaced and the facility needs upgrades. All to serve the needs of the Lewis County residents; and,

WHEREAS, The proposed fee increases are as follows: tipping fee \$100/per ton with a minimum of \$15/200lbs, bulky waste \$120/ton with a minimum of \$15/200lbs, yard waste (grass & leaves) \$90/ton with a minimum of \$10/160lbs, yard waste (tree limbs) \$60/ton with a minimum of \$10/160lbs and tires (passenger/light truck) \$5 with or without the rims.

WHEREAS, under Chapter 70.95, RCW, the new tipping fee would be effective at least seventy-five (75) days after haulers have been given notice so that solid waste collection companies have sufficient time to prepare and submit tariffs and rate filings for public comment; and to allow time for the Washington Utilities and Transportation Commission time to review the collection companies' tariff requests.

NOW, THEREFORE BE IT RESOLVED, that the 25th day of October, 2021, at or after the hour of 1:30 P.M., in the Commissioners' Hearing Room on the 2nd floor of the Historical Courthouse in Chehalis, Washington, has been fixed by said Board of the District as the time and place for the hearing on said proposed fee increases listed above effective February 1, 2022, when and where all persons may appear and be heard upon said proposal; and that the Clerk of the Board is hereby instructed to proceed with all necessary notifications, posting, and publication.
