North Street, Chehalis, Washington, on the 14th day of December 2021. The hearing will be held on or after 10:00 a.m. to consider an amendment to various departments within the 2021 budget for Current Expense and various funds, increasing expenditures in the amount of \$3,013,600, offset with an increase in revenue in the amount of \$3,530,915 and a increase of fund balance of \$517,315; and

**NOW THEREFORE BE IT FURTHER RESOLVED** the BOCC hereby consents to allow 2021 budget appropriations for salaries and benefits to be expended on operational costs and Current Expense budgets are amended to be set at the department level and other funds are to be set at the fund level and to allow approved changes between line items; and

**NOW THEREFORE BE IT FURTHER RESOLVED** that the BOCC hereby instructs the Clerk of the Board to proceed with all appropriate and necessary notifications, posting and publication for the hearings as required by law.
