PUBLICATION OF 2021 COUNTY FORCES ROAD
CONSTRUCTION PROJECTS AND COSTS

WHEREAS, pursuant to RCW 36.77.070, construction completed by county forces, where the cost of the work exceeds \$10,000, must be published in one issue of a newspaper of general circulation in the county with a brief description of the work, together with the true and complete cost of performing such construction by county forces; and

WHEREAS, construction by county forces is defined in WAC 136-18-020 as construction work performed by personnel carried on the county payroll using county owned, leased or rented equipment.

NOW THEREFORE BE IT RESOLVED by the Board of County Commissioners that the following road construction was completed by county forces in the calendar year 2021 at the cost shown and is hereby directed to be published in compliance with RCW 36.77.070. Costs shown do not include engineering, right of way charges, or county forces expenditures less than \$10,000.

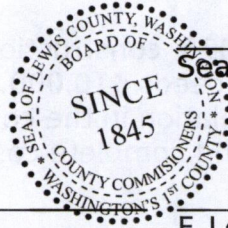

NOTICE IS HEREBY GIVEN that the Board of County Commissioners (BOCC), Lewis County, Washington, intends to sell tax parcel 003088 001 001, consisting of 0.27 acre of land located off N Pearl Street, Centralia. The below described property was conveyed to Lewis County by the County Treasurer following an unsuccessful attempt to sell the property at public auction. The County has received an offer to purchase the property for \$1,187.22, the amount of unpaid taxes and miscellaneous Treasurer's fees. RCW 36.35.150 allows for the disposal of the property by private negotiations providing that the final sale price is no less than the principal amount of the unpaid taxes. Notice of the BOCC's intent to sell the property is hereby given to the public as required by LCC 3.30.400, thereby providing an opportunity to compete for purchase by offer of more favorable price

Purchaser shall have five days from the date of award to pay for the property in cash or by cashier's check. Upon payment to the County Treasurer in the Courthouse, Chehalis, Washington, a Treasurer's Deed will be issued for the property. The County reserves the right to reject any and all offers.
