THE TEMPORARY CLOSURE OF CENTRALIA ALPHA
ROAD TO ALL THROUGH TRAFFIC

WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, it is necessary for Lewis County to replace a culvert on Centralia Alpha Road from milepost 15.71 to 15.92; and

WHEREAS, it will be necessary to close Centralia Alpha Road on each side of the culvert replacement area to all through traffic during the period of such project work; and

WHEREAS, Centralia Alpha Road will remain open for local access up to, but not beyond, the point of closure, and alternate routes are available to access residences beyond the closure.

NOW THEREFORE BE IT RESOLVED that, pursuant to RCWs 47.48.010 and 47.48.020, beginning July 11, 2022, and ending September 30, 2022, Centralia Alpha Road from milepost 15.71 to 15.92 in Section 15, Township 13 North, Range 1 East West, W.M., shall be closed to all through traffic.

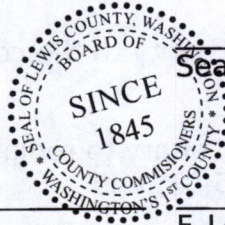


NOTICE

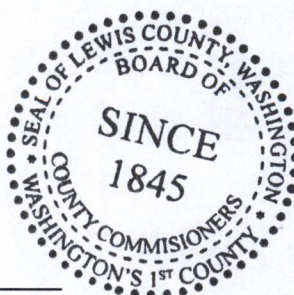
Title VI Notice to Public

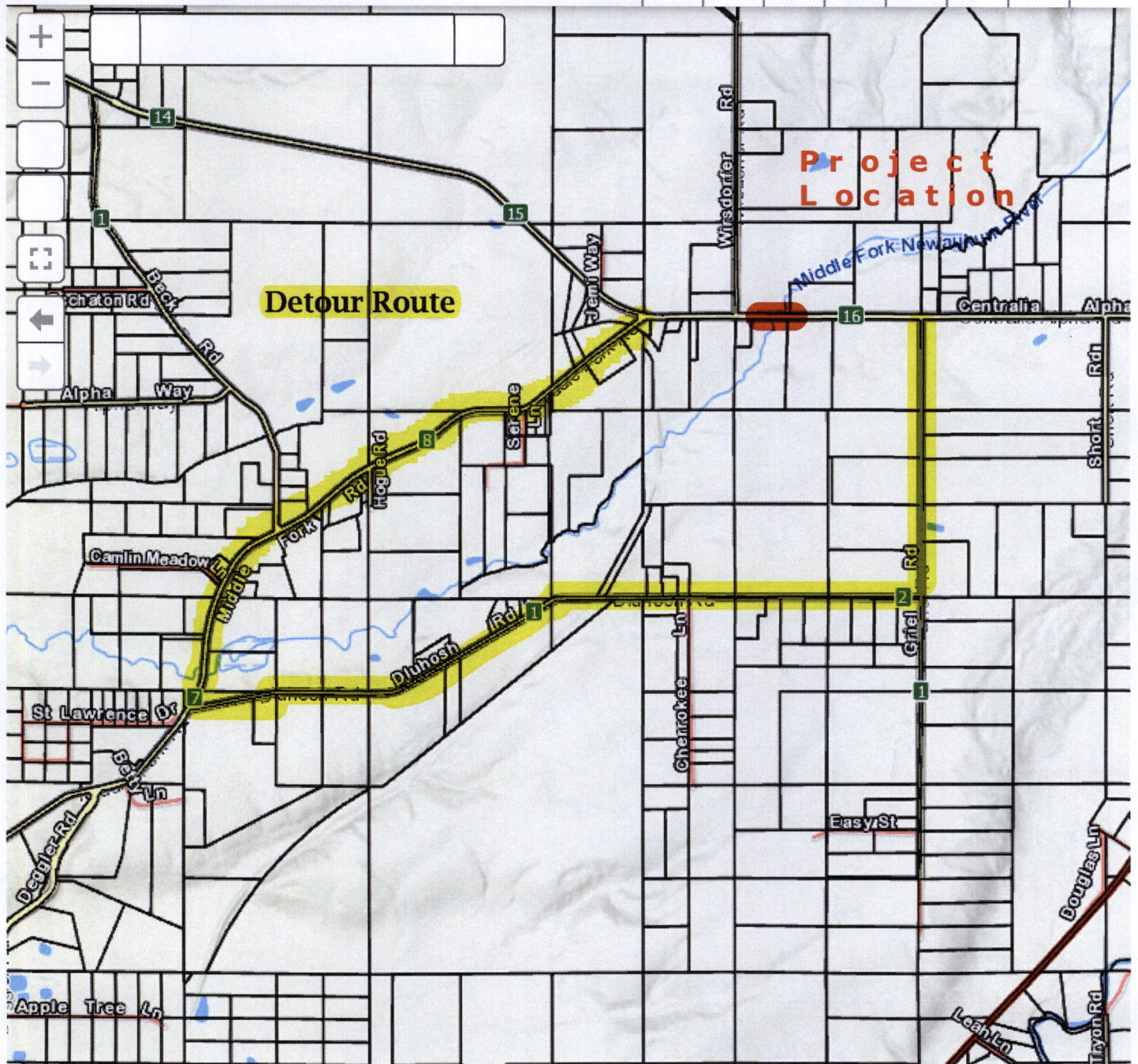

Lewis County plans to construct a 22-ft span concrete box culvert on Centralia Alpha Road crossing the Middle Fork Newaukum River. It will be necessary to close Centralia Alpha Road from milepost 15.71 to 15.92 to all through traffic during construction. Centralia Alpha Road will remain open for local access from either end up to, but not beyond, the point of closure. This resolution would, pursuant to RCW 47.48.010 and .020, close Centralia Alpha Road from milepost 15.71 to 15.92 in Section 15, Township 13 North, Range 1 East West, W.M., beginning July 11, 2022, and ending September 30, 2022.
