The hearing will be held at or after 10:00 a.m. to consider an amendment to various departments within the 2022 budget for Current Expense and various funds, increasing expenditures in the amount of \$2,888,532, an increase in revenue in the amount of \$1,098,149 and use of estimated ending fund balance in the amount of \$1,790,383; and

NOW THEREFORE BE IT FURTHER RESOLVED that the BOCC hereby instructs the Clerk of the Board to proceed with all appropriate and necessary notifications, posting and publication for the hearings as required by law.

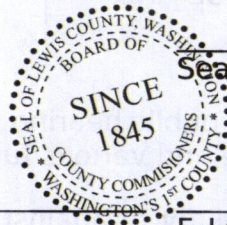
