On September 21, 2022 the County Road Engineer filed his report in writing with the Lewis County Board of County Commissioners (BOCC) setting forth all things required by law to be set forth in the county engineers report.

On September 27, 2022, the BOCC passed Resolution 22-291, which fixed the 11th day of October, 2022, at or after the hour of 10:00 A.M., in the Commissioners Hearing Room on the 2nd Floor of the Historic Courthouse, Chehalis, Lewis County, Washington, as the time and place for the hearing on the report of the County Engineer, and that the BOCC duly caused notice thereof to be published and posted as required by law.

NOW THEREFORE IT IS ORDERED the vacation of Meyers Road No. 1096 Right of Way outside Mossyrock, as shown in Exhibit A, came regularly on for hearing, and due proof having been made to the satisfaction of the BOCC by affidavit of the posting and publication of the notices of hearing and BOCC having considered the engineer's report and all the evidence relative to such vacation, now here finds that Meyers Road is not useful to the County road system and of the Order of Vacation No. 22-003 is approved..

TO THE BOARD OF COUNTY COMMISSIONERS:

I, the undersigned County Engineer of Lewis County, Washington, to whom was referred on the 13th day of September, 2022 by Resolution 22-291, ordering me to examine all that portion of Meyers Road No. 1096 in the Government Lot 12 in Section 5, Township 12 North, Range 3 East, W.M., stating that said Board intends to proceed to determine whether said road should be vacated and abandoned for the reason that it is useless as a part of the County road system and that the public will be benefited by its vacation and abandonment, herewith submit my report thereon:

FIRST: The Meyer Road No. 1096 was declared to be a county road by resolution 89-54, February 16, 1989 at a width of 60 feet.

SECOND: The portion of right of way proposed for vacation is approximately 957 feet in length and is maintained by the County.

THIRD: The road is adjoined by property owned by Stephen Anderson, who has requested this vacation, and Port Blakely who has agreed to this vacation.

FOURTH: This portion of right of way does not abut a body of water, nor is the right of way necessary as part of the county road system and is useless for County road purposes.

FIFTH: The Property Owner has paid all administrative fees and publication costs associated with this vacation.


SIXTH: Utility companies known to service the general area have been contacted and are not opposed to the vacation.


