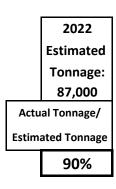

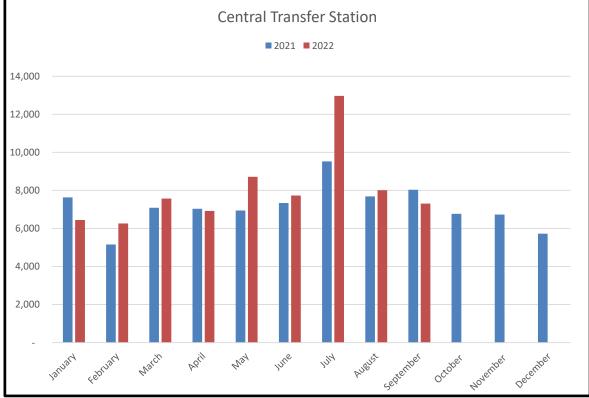

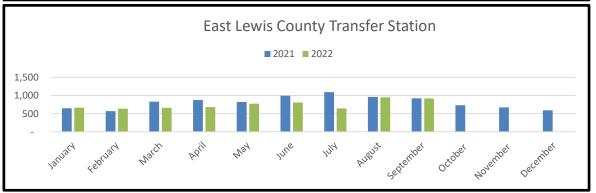

*Breakdown of building/facility rent: CTS monthly rent is \$51,000 and the ELCTS monthly rent is \$1,859. CTS monthly rent payments increased from \$38,700 to \$51,000 in January 2010. \$38,700 provides funding for bond payments and \$12,300 is reserved in the Solid Waste Fund 401 for capital improvements. Per BOCC Resolution #19-292, when the bond is fully paid in December 2024, the entire \$51,000 payment will be accounted for in the Solid Waste capital improvement reserve.
