
WHEREAS, said Engineer's Report and all related materials have been reviewed by the Board and found appropriate for further proceedings.




JOPPISH ROAD – 40 miles per hour (MP 0.286 to MP 1.775).

A hearing on the reduction of the speed limit on Joppish Road in Lewis County will be held on the 6th day of February, 2012, at or after the hour of 10:00 a.m., in the Commissioners Hearing Room on the 2nd floor of the Historical Courthouse in Chehalis, Washington, when and where all persons may appear and be heard concerning the reduction of the speed limit.

Lewis County policy requires that notice of hearing be advertised at least 10 days before the day fixed for hearing, and also published once in the official newspaper of the county.
