RESOLUTION NO. 12 036

WHEREAS, Lewis County Code 12.10 regulates the movement of overlegal vehicles on all county roads in Lewis County, and

WHEREAS, situations occur where numerous overlegal vehicles travel a short distance on county roads to a specific destination on a regular basis, and

WHEREAS, in such situations, it would be more expedient for the County and the destination Company to enter into a haul route agreement whereby the County waives permitting for movement of overlegal vehicles and the Company agrees to accept responsibility for any and all damages to the road resulting from such movements, and

WHEREAS, all other requirements specified in Lewis County Code 12.10 remain in effect, and

WHEREAS, an amendment to Lewis County Code 12.10 to allow haul route agreements in certain instances in lieu of permitting would save the County administrative expense as well as being more convenient and efficient for operators of overlegal vehicles.

NOW, THEREFORE, BE IT RESOLVED that the 13th day of February, 2012, at or after the hour of 10:00 a.m., in the Commissioners Hearing Room on the 2nd floor of the Historical Courthouse in Chehalis, Washington, has been fixed by said Board as the time and place for the hearing to consider amending Lewis County Code 12.10 when and where all persons may appear and be heard upon the repeal of this county code;

BE IT FURTHER RESOLVED that the Clerk of the Board is hereby instructed to proceed with all appropriate and necessary notifications, posting and publication.






NOTICE OF HEARING

NOTICE IS HEREBY GIVEN that on the 13th day of February, 2012, the matter of amending Lewis County Code 12.10, regarding the overlegal movement of vehicles on Lewis County roadways will be heard.

Said amendment would allow permits to be waived in situations where overlegal vehicles travel a short distance on county roads to a specific destination on a regular basis, and where the destination Company has entered into a haul route agreement with Lewis County agreeing to be responsible for any and all damage done to the county roadway during said overlegal movements.
