WHEREAS, Lewis County Fire District #5 has agreed to use Lewis County's established Small Works Roster in a manner that is consistent with procedures used by Lewis County; and

WHEREAS, it appears to be in the best public interest to authorize the execution of said Interlocal Agreement for Lewis County;

NOW THEREFORE BE IT RESOLVED, that an Interlocal Agreement approving Lewis County Fire District 5's use of Lewis County's Small Works Roster is hereby approved and the Chairman of the Board of County Commissioners is authorized to sign the same.

EXHIBIT “A”

INTERLOCAL AGREEMENT

BETWEEN LEWIS COUNTY FIRE DISTRICT NO. 5

AND

LEWIS COUNTY

THIS CONTRACT is entered into between the COUNTY OF LEWIS, a municipal corporation located in the State of Washington, hereinafter "COUNTY", and Fire District Five a municipal corporation formed under the Revised Codes of Washington, hereinafter "DISTRICT".

WHEREAS, the COUNTY has an established Small Works Roster; and

WHEREAS, Fire District Five is in need of the use of a Small Works Roster and RCW 39.04.155(2)(b) establishes guidelines for Interlocal Agreements allowing other state agencies use of an established Small Works Roster; and

NOW, THEREFORE, in consideration of the terms, conditions, and covenants contained herein, the parties agree as follows:

I. USE OF LEWIS COUNTY'S SMALL WORKS ROSTER

County is in agreement with District's use of the established Small Works Roster. County agrees to implement and maintain their small works roster by following the provisions in RCW 39.04. County has sole discretion in determining the procedures, content, and form of the small works roster so that it complies with RCW 39.04.

This Interlocal Agreement shall not relieve either party of any obligation or responsibility imposed upon it by law, nor shift liability to the other party for any violations of applicable law.

District agrees to utilize the established Small Works Roster in a manner that is consistent with that of the County and will report usage in a timely manner to the Director of Public Works.

II. DURATION & TERMINATION

This agreement may be terminated by either party by providing thirty (30) days written notice to the other party.

This Interlocal Agreement becomes effective on the date of the final approved signature and shall remain in effect until terminated by either Lewis County or Fire District No. 5.

III. CHANGES AND MODIFICATIONS

This agreement may be modified upon the written agreement executed by both parties. No course of dealing between the Parties shall be construed to alter the terms hereof, except as expressly stated herein.

IV. HOLD HARMLESS AND INDEMNIFICATION

Fire District Five shall hold harmless the County for any negligent act or omission by the County regarding the creation, maintenance, policies, and use of the County's small works roster, including but not limited to, any inconsistency or conflict between the requirements of state law and either the County's small works roster or the County's small works roster policy.

This Agreement is executed by the persons signing below who warrant that they have the authority to execute this Contract.

The parties have caused this Contract to be executed in duplicate originals this 5 day of March, 2012.

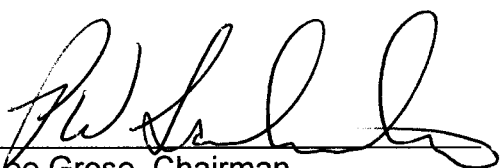
