**WHEREAS**, Resolution 13-458, passed by the Board of County Commissioners on August 26, 2013, directed the County Engineer to examine a portion of 3<sup>rd</sup> Street, Dryad, and report his opinion to the Board of County Commissioners; and

**WHEREAS**, as required by RCW 36.87, on the 25<sup>th</sup> day of September, 2013, the Report of the County Engineer on the matter of the proposed vacation of the following described portion of 3<sup>rd</sup> Street, Dryad was filed in the office of the County Commissioners of Lewis County, Washington, to wit:

All that part of 3rd Street dedicated to the public in the Plat of Dryad, recorded in Volume 3 of Plats, Pages 106-108, records of Lewis County, lying North of Olive Street, in Section 1, Township 13 North, Range 5 West, W.M.


**WHEREAS**, the report and all related materials having been reviewed by the Board and found appropriate for further proceedings,

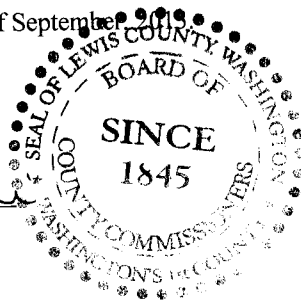

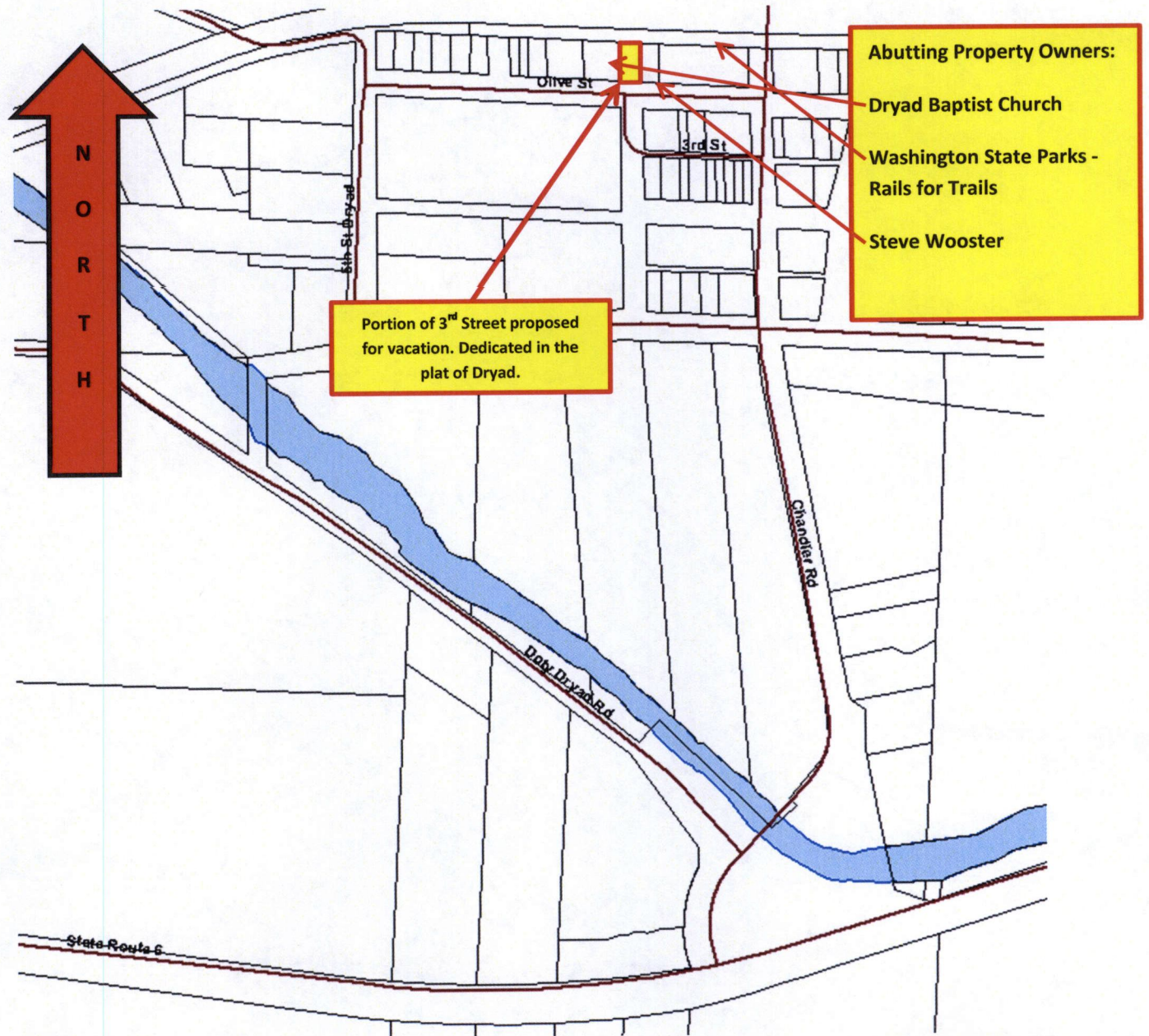
