AUDIT SUMMARY

Results in brief

In the areas we audited, County operations complied with applicable requirements and provided adequate safeguarding of public resources. The County also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Lewis County from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the County's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General revenue
- General expenditures
- Open Public Meetings Act
- Cash receipting
- Treasurer's Office
- Financial condition
- Payroll
- Health Department
- Procurement
- Restricted funds/cost allocation
- Utilities
- Disbursements

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the County's major federal programs, which are listed in the Federal Summary section of the financial statement and single audit report.

INFORMATION ABOUT THE COUNTY

Lewis County is home to more than 75,200 residents. Historically a logging and agricultural county, Lewis County's economy is in transition. The County is moving towards a more diversified economy including construction, manufacturing, retail, healthcare, transportation and warehousing, utilities, and public employment sectors.

An elected, three-member Board of Commissioners administers the County, which operates on a \$115 million annual budget. Its 698 full- and part-time employees provide public safety (Sheriff and Court services), construction and maintenance of roads and bridges, health and social services, cultural and recreational facilities and services, planning and zoning services, and general administrative services.
