



Shoreline Master Program Periodic Review

The Shoreline Master Program (SMP) contains local land-use policies and regulations that guide the use of Lewis County shorelines. They protect resources for future natural generations, provide for public access to public waters , and plan for waterdependent uses. The Shoreline Management Act requirements each SMP be reviewed and revised , if needed, on an eight-year schedule. The periodic review ensures that the SMP

- stays current with changes in laws and rules,
- remains consistent with other Lewis County plans and regulations, and
- is responsive to changed circumstances, new information, and improved data

The SMPs policies and regulations apply to:

- Lakes and reservoirs greater than 20 acres
- Streams or rivers with mean annual flow over 20 cubic feet per second
- Lands within 200' of the shoreline areas, the FEMA floodways, contiguous floodplain areas landward 200' from the FEMA floodways, and associated wetlands
