WHEREAS, RCW 47.48.010 gives authority to the county legislative authority to close roads for a period of time; and

WHEREAS, it is necessary for Lewis County to replace a culvert on Lakeside Drive at milepost 0.22; and

WHEREAS, it will be necessary to close Lakeside Drive between Streamside Drive and Lake Drive to all through traffic during the period of such project work; and

WHEREAS, Lakeside Drive will remain open for local access from either end up to but not beyond the point of closure at milepost 0.22, and other county roads are available for detour.

NOW THEREFORE, BE IT RESOLVED that, pursuant to RCW. 47.48.010 and .020, beginning September 5, 2017 and ending September 13, 2017, Lakeside Drive between Streamside Drive and Lake Drive, in Section 28, Township 12 North, Range 2 East, W.M., shall be closed to all through traffic.





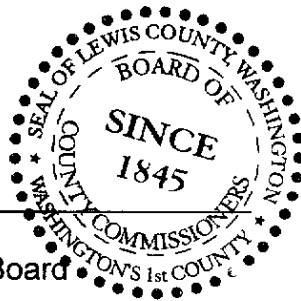
NOTICE OF HEARING
